Families eligible for USDA food also receive "pantry food" containing food that is entirely purchased by Loaves & Fishes or donated by individuals and businesses. Families who are not eligible for USDA food may receive pantry food. Families may receive groceries only once each month.

Loaves & Fishes maintains a database of information about each household, including names of each individual in the household, addresses, telephone numbers, eligibility information, and the dates on which groceries are received. Recipients are required to sign electronically to ensure that groceries are not received more than once a month.

Number of recipients is calculated by adding up total of individuals served each month. Each family is eligible to receive food once per month, so each individual would be counted each month their family applies for food assistance.
